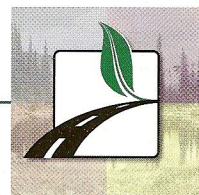

### 'Zero Emissions'!

Did you know that the PbA Ranger is a Zero Emission Vehicle (ZEV)?

Thanks to its evolutionary electric power system, the PbA Ranger is one of the cleanest vehicles in the world! This system offers a Power Control Station which is a separate piece of equipment used to charge the electric vehicle drive batteries. The Power Control Station provides a link between the stationary electric power source and your vehicle and works when wired to a 208 -240 volt, 32 amp electric service source.

The Power Control Station and its installation are not included in the lease price of the Ranger, and must be individually contracted by the customer. For a list of approved distributors, contact your EV approved Ford Dealer or call 1-877-ALT-FUEL.

### Electric

In North America, more than 50 Ford EV Certified Dealers sell and service our electric Ranger.

### Natural Gas

A North American network of nearly 400 Ford Dealers participate in the Natural Gas program and may offer sales and service for Natural Gas vehicles.

Servicing Natural Gas vehicles requires specialized tools and training. ### Propane

All Ford dealers may sell and service Ford Propane Vehicles (F-Series Bi-Fuel Super Duty vehicles not available in Canada.) Dealer must take training through FCSD to ensure product and service quality.

### Flexible Fuel

Flexible Fuel vehicles (FFVs) can be ordered and serviced through any North American Ford dealership including those vehicles that meet California emission standards.
